# AUDITOR'S REPORT ON THE ACCOUNTS OF THE SPORTS CO-OPERATIVE GROUP HOUSING SOCIETY LTD.,

### FOR THE CO-OPERATIVE YEAR ENDED ON 31ST MARCH, 2022.

The observations in Part-A, Part-B and Part-C are an integral part of the attached Balance sheet of the Sports Co-operative Group Housing Society Ltd. as on 31st March,2022 together with the Income & Expenditure Account and Receipt & Payment Account of the above-referred Co-operative Society for the year ended on that date.

#### PART-A

#### Observations made in the Part "C" of the pervious Audit Report:

- 1. The observation regarding tripartite Agreement among the Society, Owner and Tenants.

  The issue is still pending and the M.C of the society is not interested in such Tripartite Agreement.
- 2. Website of the Society be created and all documents including audit report be uploaded on it.

No action has been taken by the Society.

3. Member's register of the society is in very dilapidated state. Its content should be rerecorded in a new register and it would be better to digitize all the old records of the Society.

No action has been taken by the Society.

4. The turnover of the Society is nearing Rs.20 lakhs and once it crosses 20 Lakhs, the GST would become applicable on Parking charges, Security Guard Services and Interest on arrears.

No action has been taken by the Society.

- 5. The Fixed Assets Register has been maintained on an excel sheet on computer but additions and alteration in flat area has not been recorded. The Society should take out prints of it and record it in a separate file, which should be signed by the President and secretary of the Society.
  - Society has prepared the Fixed Assets Register on Form # 24 (see Rule as prescribed under The Delhi Co-operative societies Rules 2007 & attach with Audit Report.
- **6.** The Managing Committee of the Society is advised to enhance the Maintenance Charges to meet the huge shortfall between the society income and expenses.

The society has enhanced the Maintenance Charges w.e.f. 01st April,2022.

#### PART-B

a) Is the society functioning from the Registered Office and the members are being allowed to inspect documents of the society including audit report as per provision of Delhi Cooperative Societies Rules 1973. In addition, the auditor is required to comment on each item of Profit & Loss Account and the Balance Sheet along with all.

The nephew of an employee had kidney problem and asked for monetary help for kidney transplant. The Society collected funds for this cause from its members and gave Rs.76,000/- in Cash to Employee Mr. Khem Chand. This amount should have been paid by A/c Payee Cheque.
